- 1) The parents/guardians submitting this form are those having legal custody over the child/children and as such are legally able to sign this form. Conditions of custody, if applicable, will be fully communicated in writing to camp, including a photocopy of the section of any court order referring to visitation rights.
- 2) I understand and certify that my child's/children's participation in Kingswood Camp and its activities is completely voluntary, and I have familiarized myself with the camp's programs and activities in which my child/children will be participating and that signing this release is a fundamental condition to Kingswood Camp accepting my child/children to the camp and its activities and this waiver release is solely for the benefit of Kingswood Camp.
- 3) I recognize that certain hazards and dangers are inherent in Kingswood Camp's events and programs, and particularly, but not limited to, the activities of using the zipline, swimming, and other water activities, archery, mudpit, low ropes course, bouldering wall a wide variety of field games, night games and canoeing and I acknowledge that although Kingswood Camp has taken safety measures to minimize the risk of injury to camp participants, Kingswood Camp cannot insure nor guarantee that the participants, equipment, premises, and/or activities will be free of hazards, accidents and/or injuries. I, the parent or guardian of the named participants on this form, release Kingswood Camp Society, its board, directors, employees, staff, cabin leaders, agents and volunteers from any loss, personal injury, accident, misfortune or damage to the named participants on this form or his/her/their property, and waive all my/our rights and claims for damages including but not limited to negligence. I further recognize and have instructed my child/children in the importance of knowing and abiding by the camp rules, regulations, and procedures for the safety of camp participants.

Behaviour Policy

Any behaviour that puts the participant/camper, other campers, volunteers, or staff members at risk will be grounds for immediate dismissal from camp. Such behaviours may include aggression, violence, unsafe use of equipment, bullying, leaving camp property, sexual aggression, as well as any other behaviours deemed inappropriate at the Executive Director's discretion. The camp staff will give such campers ample warning that the behaviour is inappropriate and, if the behaviour is not deemed too extreme, the camper will be given 3 opportunities to correct the behaviour (parent or guardian will be called at this time). Should the camper fail to use these 3 opportunities to change/correct the behaviour, he/she will then be sent home

Refund/Cancellation Policy

- 1) The Kingswood Camp Executive Director reserves the right to dismiss without refund any camper whose behaviour is deemed unsuitable, who appears to have rejected the reasonable controls of camp in their opinion and to dismiss a camper if said camper is a hazard to the safety and rights of others on camp property.
- 2) There will be no refund if your child is sent home with an illness or due to behaviour during the week.
- 3) A refund will be given in the event of a cancellation if it is **1 week** prior to the camp registered. **The \$50.00 security deposit is NOT refundable.**

Medical Waiver

In case of emergency, I hereby give permission to camp staff to provide my child with appropriate and necessary first aid and medical treatment, including the dispensing of prescribed medication sent with the camper. My signature as the parent/guardian on this application shall give the Primary Leadership Team the right to approve and obtain medical attention necessary for the camper's welfare and good health including ordering injection, anesthesia or surgery. In such situation the camp will make all reasonable efforts to contact the guardians as soon as possible.
